Located just off Driver Way on the popular residential area of Stanton Cross is this excellent three bedroom semi detached property which benefits from a 17ft kitchen/dining room with built in appliances, an ensuite shower room to the master bedroom, uPVC double glazed windows and gas radiator central heating. The property further benefits from a cloakroom, an 11ft third bedroom, off road parking for two vehicles and a west facing rear garden. The accommodation briefly comprises entrance hall, lounge, inner hallway, cloakroom, kitchen/dining room, master bedroom with ensuite shower room, two further bedrooms, bathroom and off road parking.

Front - Hedging and iron rails, driveway providing off road parking for two vehicles.

Rear - West facing, patio area, mainly laid to lawn, enclosed by panel fencing, water tap, pedestrian gated access.
