The property benefits from gas radiator central heating, uPVC double glazed doors and windows, a refitted kitchen with built in appliances and offers a rear garden of 54ft in length. The accommodation briefly comprises entrance hall, lounge/dining room, kitchen, three bedrooms, bathroom, gardens to front and rear and a garage.**
