Garage - Up and over door, power and light connected, plumbing for washing machine, space for fridge/freezer, personnel door to hallway. Measures 18' 1" x 8' 4" internally.

Rear - Low maintenance and landscaped garden comprising two patio areas, borders stocked with shrubs and bushes, wooden shed, enclosed by wooden fencing with gated side pedestrian access.
