The land is located at the north east end of the village of Stathern, in the Vale of Belvoir, with gated vehicular access directly off Blacksmith End.

The Land

The land extends to approximately 2.81 acres of permanent pasture. It is bordered on all four boundaries by strong hedges, making it ideal for equestrian and livestock use.

Tenure

Freehold with vacant possession on completion.
