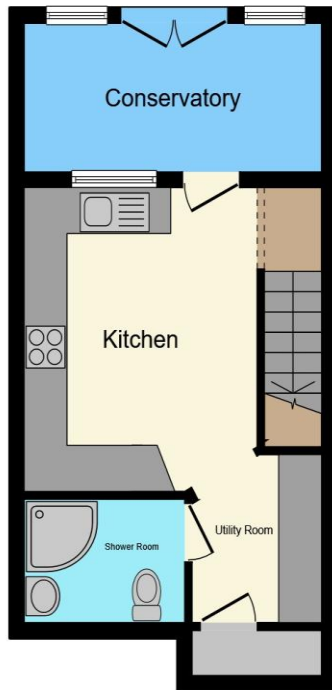

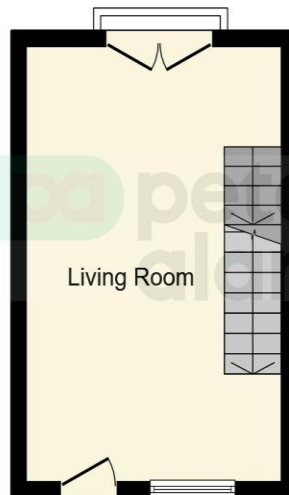

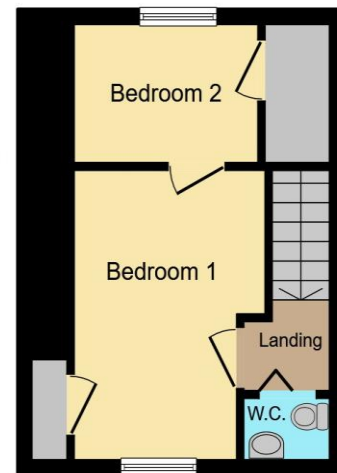
Floorplan
