The property also benefits the addition of a conservatory, a rear garden, block paved driveway providing off road parking, gas radiator central heating and uPVC double glazing. The accommodation briefly comprises entrance hall, lounge, dining room, kitchen, conservatory, three bedrooms, shower room, gardens to front and rear, garage, outside W.C., and a driveway.

Rear - Patio area, mostly lawn with borders stocked with bushes, shrubs and trees, outside W.C., vegetable plot, enclosed by wooden fencing with gated side pedestrian access.
