Located centrally in the Stoke area of Plymouth, close to a host of local amenities, well-regarded schools, local parks and a stone's throw away from the city centre and provides easy access to major transport links.

The accommodation comprises, a spacious lounge with bay window, a separate dining room, kitchen, two good-sized double bedrooms, one single bedroom and a large bathroom.

Externally, this property offers a rear garden and on-street parking.

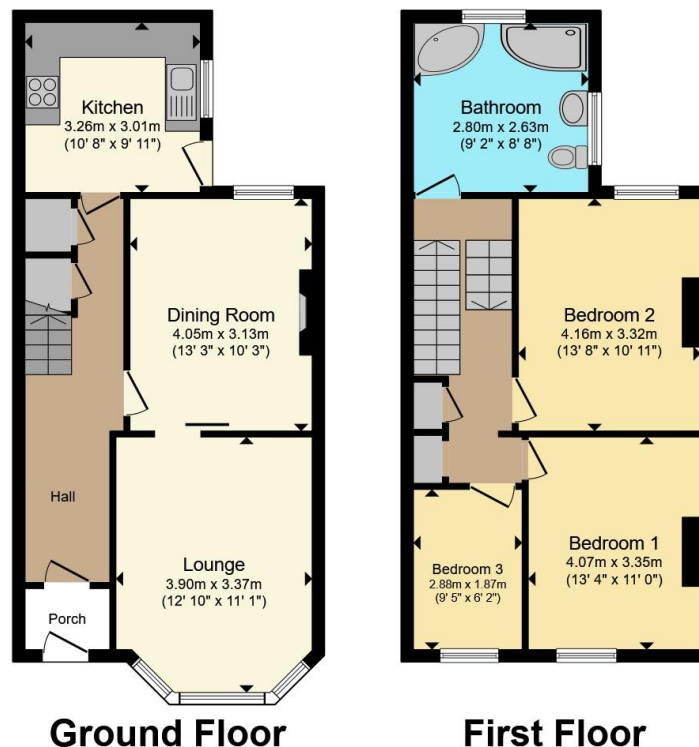
