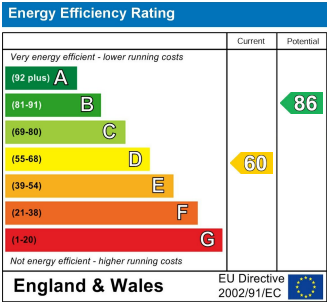

Directions

From Banbury town centre proceed in a northwesterly direction along the Warwick Road (B4100). Continue to the second of two mini roundabouts and turn right opposite the arcade of shops into Ruscote Avenue. The property will be found after the turning for Sinclair Avenue on the left and can be recognised by our "For Sale" board.

Situation

BANBURY is conveniently located only two miles from Junction 11 of the M40, putting Oxford (23 miles), Birmingham (43 miles), London (78 miles) and of course the rest of the motorway network within easy reach. There are regular trains from Banbury to London Marylebone (55 mins) and Birmingham Snow Hill (55 mins). Birmingham International airport is 42 miles away for UK, European and New York flights. Some very attractive countryside surrounds and many places of historical interest are within easy reach.

A floorplan has been prepared to show the dimensions and layout of the property as detailed below. Some of the main features are as follows:

- * A terraced house conveniently located for many places of work, retail areas, leisure facilities and food outlets.
- * Large mainly lawned rear garden with borders, patio and garage which is approached via Evenlode.
- * Sitting room with bay window to front and archway providing open access to the dining room.
- * Kitchen with a range of base and eye level units, electric cooker point, door to the large utility/conservatory with plumbing for washing machine, space for appliances, double doors opening to the rear garden.
- * Landing with hatch to loft.
- * Two double bedrooms and a single.
- * Bathroom fitted with a white suite comprising panelled bath, wash hand basin and WC, window.

- * Front garden with artificial grass and path to front door.
- * Scope for cosmetic improvement.
