The property in brief comprises: entrance hall, lounge, kitchen, inner hall, two good size bedrooms and a wet room. Outside, this property benefits from a driveway to the side providing off road parking for two cars and access to the attached garage. To the front of the property is a wall and fence enclosed area laid to patio with a pathway leading to the front door and a range of shrubs. The rear garden is fully fence panel enclosed and mainly laid to patio with planters and areas of gravel. Early internal viewing is strongly recommended to appreciate this property in full.
