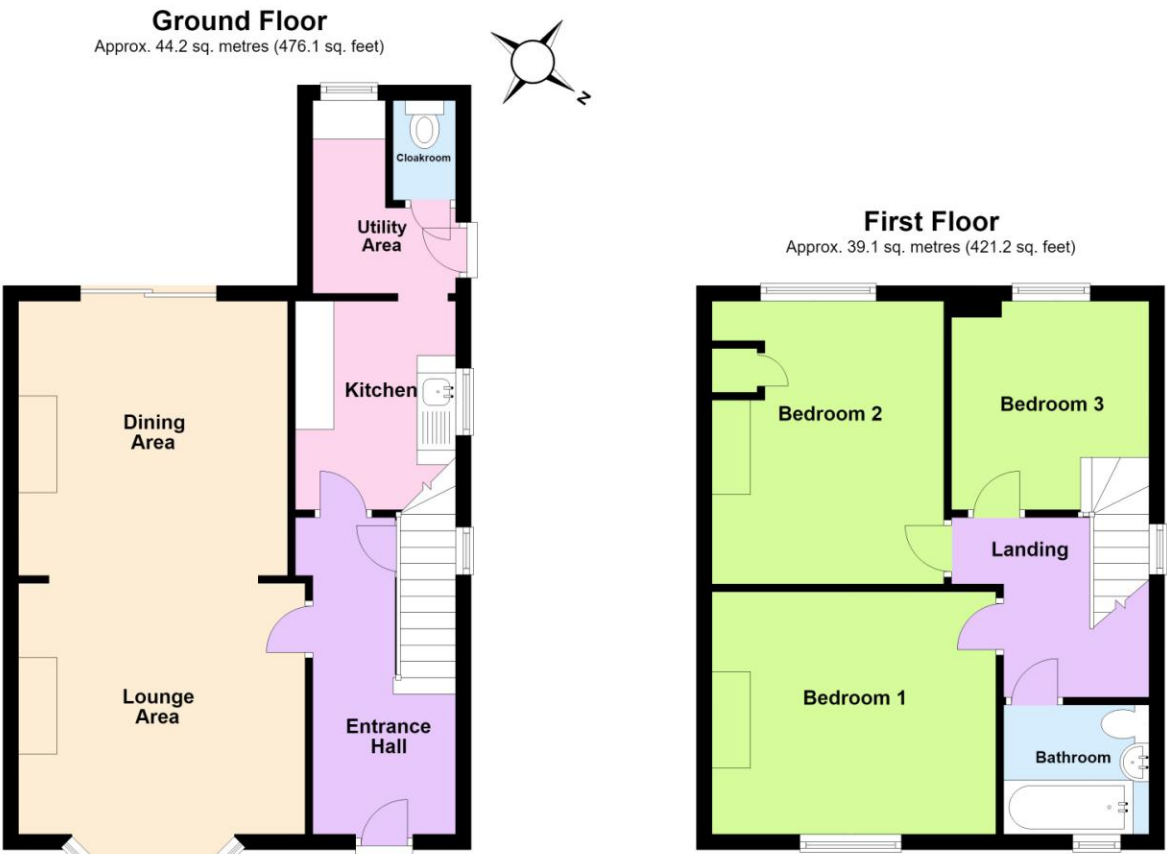

Offered with no upward chain and situated off Wellingborough Road is this mature bay fronted three bedroomed semi detached property featuring gas radiator central heating and uPVC double glazing however would benefit from some upgrading and refurbishment. The property further offers a 25ft lounge/dining room, mature garden measuring approx. ft in length and three good sized bedrooms. The accommodation briefly comprises entrance hall, lounge/dining room, kitchen, cloakroom, utility area, landing, three bedrooms, bathroom, front and rear gardens.
