The porch leads to the entrance hall which has laminate flooring and access to the lounge featuring a gas fire with a marble hearth and surround, laminate flooring, and a sliding door to the dining room which has laminate flooring, and a double panel radiator. The third reception room has laminate flooring and a sliding UPVC double glazed door leading to the rear garden. The kitchen is fitted with a range of cream gloss wall, base and drawer units, with space for additional appliances.

To the first floor, the landing gives access to three bedrooms, all benefiting from fitted carpets and single panel radiators. The fully tiled family bathroom comprises a large shower cubicle, a wash hand basin set within a vanity unit and WC.

Externally, the property benefits from a private rear garden, while to the front there is a driveway providing off-road parking and access to the integral garage.

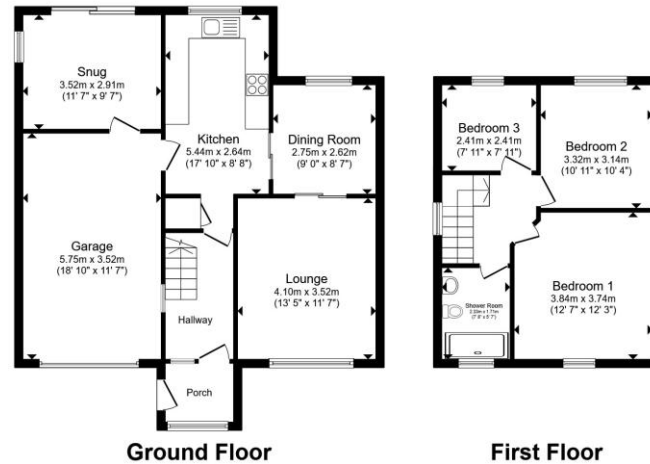
