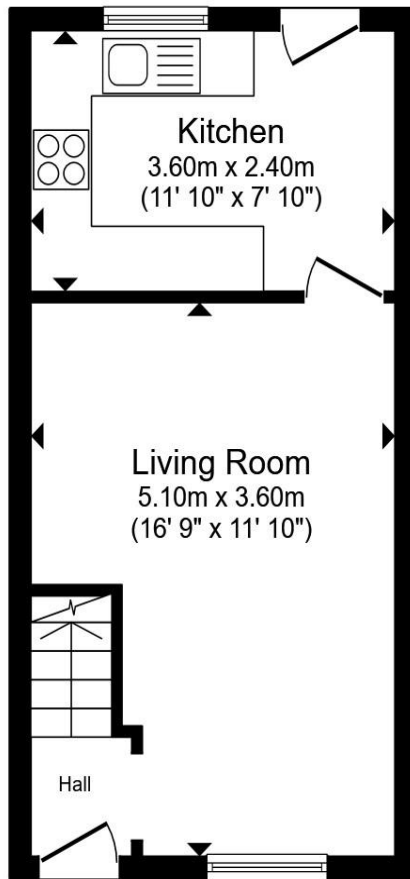
Honeysuckle Grove, Oxford

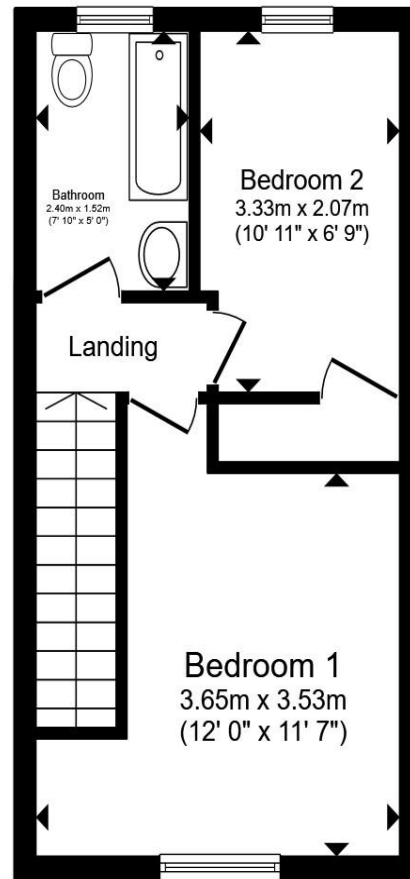
