Bedroom Two

Double glazed window to front aspect. Carpet flooring, radiator, built-in wardrobes.

Bedroom Three

Double glazed window to side aspect. Carpet flooring, radiator, built-in wardrobe.

Bathroom

Double glazed window to front aspect. Panel enclosed bath with shower over, low level WC, wash hand basin. Radiator, laminate flooring, tiled to bath area.

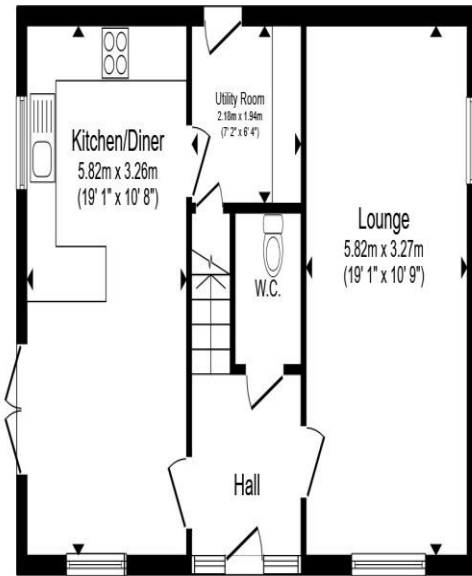

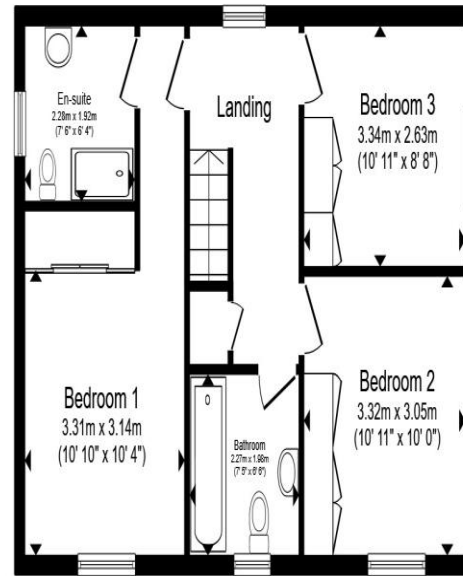
Laid to lawn with mature shrubs. Driveway providing two parking spaces, with EV charger.
